**REQUEST FOR RELEASE OF FUNDS**

On or about December 10, 2025, the County of San Joaquin (County) will submit a request to the U.S. Department of Housing and Urban Development (HUD) to request an allocation of Community Development Block Grant (CDBG) funds, under Title I of the Housing and Community Development Act of 1974 (24 CFR Part 570), as amended, and Home Investment Partnerships Program (HOME) funds under Title II of the Cranston-Gonzales National Affordable Housing Act of 1990, as amended, to undertake a project known as the Manteca Navigation Center (MNC). The MNC will include medical collaborations and support individuals experiencing homelessness in the City of Manteca. The Navigation Center will offer shelter, supportive services, and access to resources that will enable individuals to break the cycle of homelessness and achieve stability and independence. The MNC will be designed as a full-service center, including shelter beds, common areas, a health clinic, offices, supportive services, restrooms, showers, transitional housing units, supportive housing, and transportation pick up and drop off points, or similar model type that supports the individual needs of participants.

The estimated total funding for the project is \$21,031,346, including \$2,000,000 – County General Fund; \$1,094,980 – City of Manteca CDBG (SJ Co allocation) grant #s B-21-UC-06-0009, B-22-UC-06-0009 and B-23-UC-06-0009; \$500,000 – San Joaquin County CDBG grant # B-20-UC-06-0009; \$750,000 – Community Project Funding grant #B-23-CP-CA-0131; \$16,000,000 awarded 3-23-2023 – State of California HCD; and \$686,366 – HOME funds (SJ Co allocation) grant # M-23-UC-060214.

**FINDING OF NO SIGNIFICANT IMPACT**

The County of San Joaquin has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. ## **PUBLIC COMMENTS**

Any individual, group, or agency may submit written comments on the ERR to Chris Woods, Director, County of San Joaquin Human Services Agency, 400 E. All comments received by December 9, 2025, will be considered by the County of San Joaquin prior to authorizing the submission of a request for release of funds. Comments should specify which Notice they are addressing.

## **ENVIRONMENTAL CERTIFICATION**

The County of San Joaquin certifies to HUD that Chris Woods, in his position as Director of Human Services Agency, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD approval of the certification satisfies their responsibilities under NEPA and related laws and authorities and allows the County of San Joaquin to use Program funds.

## **OBJECTIONS TO RELEASE OF FUNDS**

HUD will accept objections to its release of CDBG and HOME funds to the County of San Joaquin's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on the following bases: (a) the certification was not executed by the Certifying Officer of the County of San Joaquin; (b) the County of San Joaquin has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (e) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to Chris Anderson, AICP at [RROFSFRO@hud.gov](mailto:RROFSFRO@hud.gov). Potential objectors should contact HUD at the email addresses above to verify the actual last day of the objection period.
